## **Company Mission:**

## **Work Proposed:**

Window Restoration + Tuning

## **Job Description:**

Remove windows to our facility in Shorewood for restoration to take place. This may necessitate removing exterior storms to remove top sash which will be re-affixed after windows removed. Temporarily board up openings as requested.

Work for you double-hung windows will include:

Removing and replacing glazing.

Replacing broken glass.

Addressing damaged or deteriorated wood using Abatron Wood Restoration 2 Part Epoxy repair solution. This process clears areas of existent rot/deterioration, consolidates the wood with a liquid epoxy and is followed with an epoxy putty which is packed into place. After it has set, we sand and shape it to match surrounding structure. This includes filling any gouges or screw/nail holes

Addressing dried out wood that has developed fissures in the grain. These areas will be brushed with an epoxy slurry. This will penetrate and harden existing wood preventing further erosion and help build back up the surface before priming and painting.

On interior and exterior of windows: Paint will be removed taken to near bare wood. We then scuff sand, clean thoroughly and prime windows using Zinsser SmartPrime and Coverstain. Followed by two coats of premium latex exterior paint. Color and sheen to be selected by owner and listed below.


Once windows are fully restored. We then reinstall tuning as necessary. This will include:

Affixing top sash fully up into its opening so that when the lower sash is installed top and bottom sash meeting rails line up and latch tightly.

Removing any excess paint where it has built-up in the jams and is inhibiting proper function. Note: this is not a full strip of jams. Full strip is available on request.

All windows to receive new pulleys, sash chords and hardware. Suggested hardware pictured below.

Other options include adding weatherstripping. (Adds 30 mins time and 10 dollars materials per window)



We perform our window tuning on a time and materials basis because no two windows are the same, and because of the options you choose can greatly affect the time it takes to do each window.

We perform all work, per EPA regulations, in a lead safe manner. Removal will require lead safe set up.

Finally, you do not need to commit to a total number of windows prior to commencement. We continue work at your pleasure.

Window Restoration + Tuning - 14 hrs and \$75 Materials Per Double Hung Window (Rough + Non Binding Estimate)

All work to be performed on the basis of time and materials. Hourly work to be performed at \$75/hr. plus the cost of all materials, expendable supplies. Including set up, removal, reinstalling and cleanup.
