

## Amendment to Contract

This Amendment amends the "Contract Purchase of Service Agreement between Wisconsin Coach Lines, Inc., and the City of Waukesha Route 906, dated May 1, 2012, referred to herein as the Contract. The Contract remains in effect and unchanged except to the extent specifically amended by this Amendment.

### Recitals

The City of Waukesha is the administrator of transit services funded by Waukesha County, and in turn has contracted with Wisconsin Coach Lines, Inc., referred to as Contractor, to provide transit service on Waukesha County route 906.

Changes in circumstances now require that the Contract be amended, specifically, that Waukesha County requires amendments of the Contract's assignment and insurance provisions.

Contractor is willing to amend the Contract as required.

Now, therefore, the Contract is amended as follows:

1. The first paragraph of Section 3 of the Contract is deleted entirely and replaced with the following:

Contractor will operate bus route 906 between Waukesha County and Milwaukee, according to the routes and timetables described on the attached Appendix B, which is incorporated into this Agreement by reference. Contractor may not make any changes to the routes or schedules without the written approval of the City. Changes to the number of revenue hours of service are possible over the term of this Agreement, but such changes shall not result in a change of the cost of revenue vehicle hour.

2. Appendix B to the Contract is deleted entirely and replaced with the attached Appendix B.

3. Paragraph 8 of the Contract is deleted entirely and replaced with the following:

**8. Insurance.** Contractor shall at all times during the term of this agreement maintain in force a policy or policies of insurance, issued by an insurance company authorized to do business in the State of Wisconsin, satisfactory to the City of Waukesha, Waukesha Transit Commission and Waukesha County, with the following coverages and limits of liability:

General Liability

Bodily injury:	\$1,000,000 per occurrence, \$1,000,000 aggregate
Property damage:	\$1,000,000 per occurrence, \$1,000,000 aggregate
Excess liability umbrella:	\$1,000,000

Automobile

Bodily injury:	\$1,000,000 per occurrence
Property damage:	\$1,000,000 per occurrence, \$1,000,000 aggregate

Excess liability umbrella: \$5,000,000

Worker Compensation Statutory limits

Contractor's insurance shall be primary. Waukesha County shall be named as an additional insured and loss payee on the General Liability policy.

4. Paragraph 12 of the Contract is deleted entirely and replaced with the following:

**12. Assignment.** This Agreement shall not be assigned, transferred, hypothecated, or pledged by either party without the prior written consent of the other party, except that if the City ceases to administer the Waukesha County Transit System routes covered by this Agreement for any reason, including but not limited to termination or expiration of its transit services contract with Waukesha County, then Contractor consents to assignment of this entire Agreement to the party designated by Waukesha County in writing, and that party shall then be substituted for the City. This Agreement shall be binding upon the successors or assigns of the parties.
