Proposed Service Changes Effective 8/1/16

Route 2- Eliminate Weekday 9:15 pm trip from the Transit Center to the Westbrook Shopping Center.

Route 6 – Add Weekday 9:15 pm trip from the Transit Center to Badger Drive.

Route 9- Change routing for the majority of Weekday Outbound trips and All Saturday Trips (From Transit Center to WCTC) from W. Moreland Blvd. at Delafield St. to north on Delafield St, then west on Northview Rd. Also, add a bus stop at the Waukesha Police Station when service begins.

Route 15 Weekdays– Operate to new Meijer Store. Only operate on East Ave., Roberta Ave. and Tenny Ave. on select trips before and after school. In addition, add inbound portion to Weekday 6:15 pm trip.

Route 3/15 Saturdays- Operate to new Meijer Store. Change routing on Racine Ave., Fleetfoot Dr., and Chippewa Dr. to one way loop. Change inbound routing from East Ave. to inbound Route 3 to Tenny Ave. and Newhall, then continue north on Tenny Ave. to College Ave., College Ave. to Oakland Ave.

From Downtown to Sunset & Big Bend Road: From the Downtown Transit Center exit on to E. North St., west on E. North St. to Brook St., south on Brook St. to E. St. Paul Ave., northeast on E. St. Paul Ave. to N.W. Barstow St., south on N.W. Barstow St. to Wisconsin Ave., east on Wisconsin Ave. to W. Broadway, southeast on W. and E. Broadway to N. Hartwell Ave., south on N. and S. Hartwell Ave. to E. Newhall Ave., east on E. Newhall Ave. to Tenny Ave., south on Tenny Ave. to E. Sunset Dr., west on E. Sunset Dr. to Big Bend Rd.

From Sunset & Big Bend Road to Downtown: South on Big Bend Rd. to Rivera Dr., west on Rivera Dr. to S. East Ave., north on S. East Ave. to Roberta Ave., east on Roberta Ave. to Tenny Ave., north on Tenny Ave. to E. Newhall Ave., west on E. Newhall Ave. to S. Hartwell Ave., north on S. and N. Hartwell Ave. to E. Broadway, northwest on E. Broadway to N. East Ave., north on N. East Ave. to W. Main St., west on W. Main St. to N. Barstow St., north on N. Barstow St. to E. St. Paul Ave., southwest on E. St. Paul Ave. to Brook St., north on Brook St. to entrance to Downtown Transit Center.

Saturday route in one direction: From Tenny Ave. at E. Newhall Ave, continue north on Tenny Ave. to College Ave, east on College Ave. to Oakland Ave.

JURISDICTION: City of Waukesha, City of Pewaukee, Village of Pewaukee

From Downtown to WCTC: From the Downtown Transit Center exit on Mary St., south on Mary St. to E. St. Paul Ave., northeast on E. St. Paul Ave. to W. Moreland Blvd., west on W. Moreland Blvd. to Delafield St., north on Delafield St. to Northview Rd., west on Northview Rd. to Pebble Valley Rd., north and west on Pebble Valley Rd. to University Dr., north on University Dr. to Silvernail Rd., east on Silvernail Rd. to N. Grandview Blvd., north on N. Grandview Blvd. and Main St. to entrance to WCTC, and west on WCTC roadways to the Business Occupations Building.

From WCTC to Downtown: From the Waukesha County Technical College (WCTC) on WCTC roadways to Main St., south on Main St. and N. Grandview Blvd. to Silvernail Rd., west on Silvernail Rd. to University Dr., south on University Dr. to Pebble Valley Rd., east and south on Pebble Valley Rd. to Northview Rd., east on Northview Rd. to Irving Pl., south on Irving Pl. to W. Moreland Blvd., east on W. Moreland Blvd. to Pewaukee Rd., south on Pewaukee Rd. to E. North St., E. North St., southwest on E. North St. to the North St. entrance to the Downtown Transit Center.

Alternate Route in both directions: From the intersection of N. Grandview Blvd. and Golf Road, west on Golf Road to the Country Springs Hotel.

Loop in both directions: On private roadways off N. Grandview Blvd. to serve GE Healthcare Headquarters and MR Business Center.

Alternate Route in both directions: From Moreland Blvd. and Riverview Ave., south on Riverview Ave. to entrance driveway to County Office Building, and on county drives to entrance to County Office Building.

Alternate Route from Downtown to WCTC: From Moreland Blvd. to Airport Rd., north on Airport Rd. to Northview Rd., west on Northview Rd.

Alternate Route from Downtown to WCTC:

From W. Moreland Blvd and Delafield St., west on W. Moreland Blvd. to Irving Pl., north on Irving Pl. to Northview Rd.

Alternate Route in both directions: From Irving Pl. and Northview Rd., east on Northview Rd. to the entrance to the Waukesha County Expo Center, and on Expo Center drives within the exposition grounds.

Alternate Route in both directions: From Northview Rd. and N. Grandview Blvd., north on N. Grandview Blvd. to Woodburn Rd., and west on Woodburn Rd. to Pebble Valley Rd.

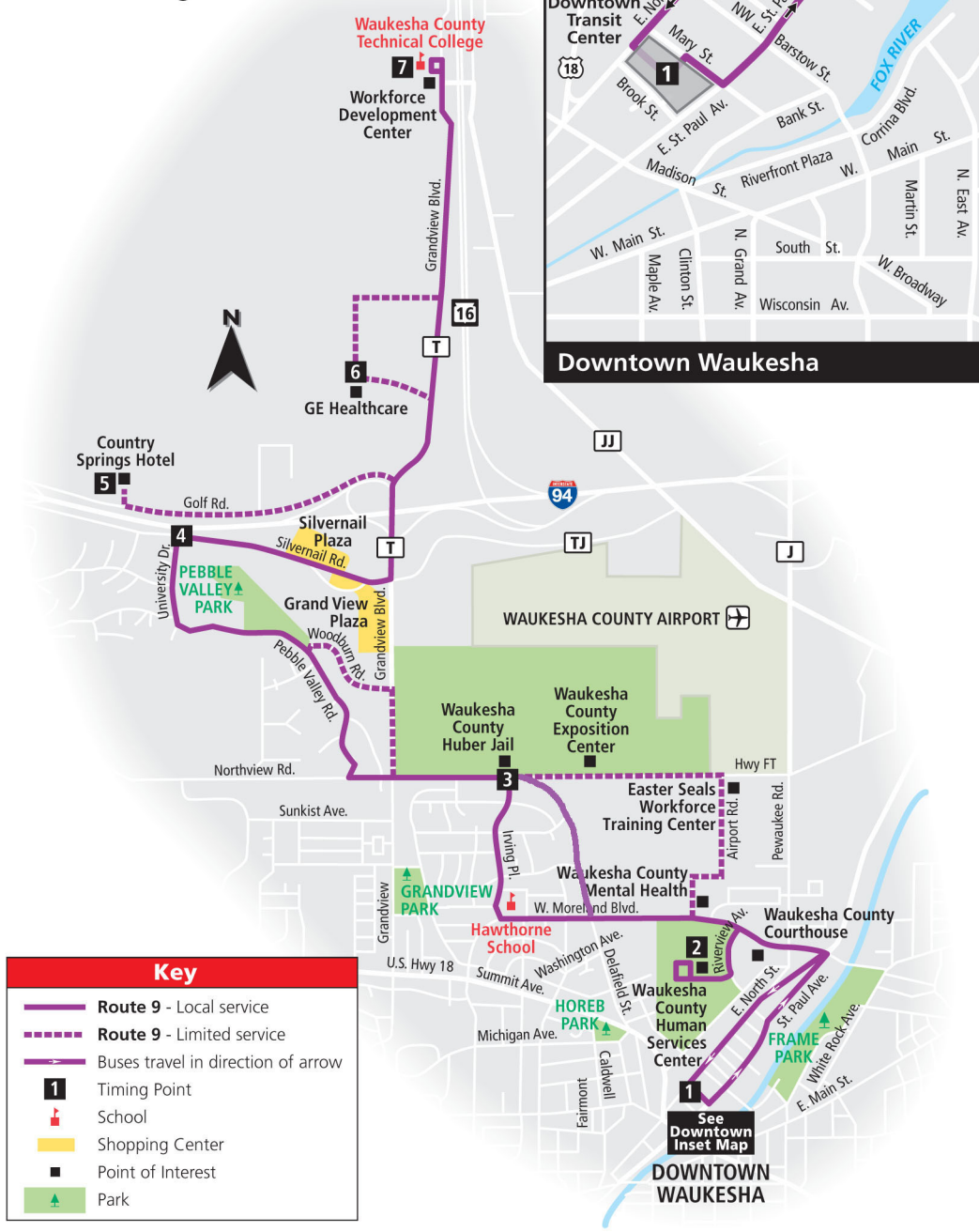

Barstow St. to Corrina Blvd., east on Corrina Blvd. to Buckley St., south on Buckley St. to Baxter St., northwest on Baxter St. to White Rock Ave., southwest on White Rock Ave. to N. Hartwell Ave., south on N. Hartwell Ave. to Lincoln Ave., east on Lincoln Ave. to Perkins Ave., south on Perkins Ave. to Frederick St., south on Frederick St. to Ellis St., west on Ellis St. to Oakland Ave., south on Oakland Ave. to Racine Ave., southeast on Racine Ave. to Fleetfoot Dr., south and east on Fleetfoot Dr. to Chippewa Dr., south on Chippewa Dr. to E. Hartwell Ave., north on N. Hartwell Ave. to White Rock Ave., northeast on White Rock Ave. to Baxter St., southwest on Baxter St. to Buckley St., north on Buckley St. to Corrina Blvd., west on Corrina Blvd. to N.W. 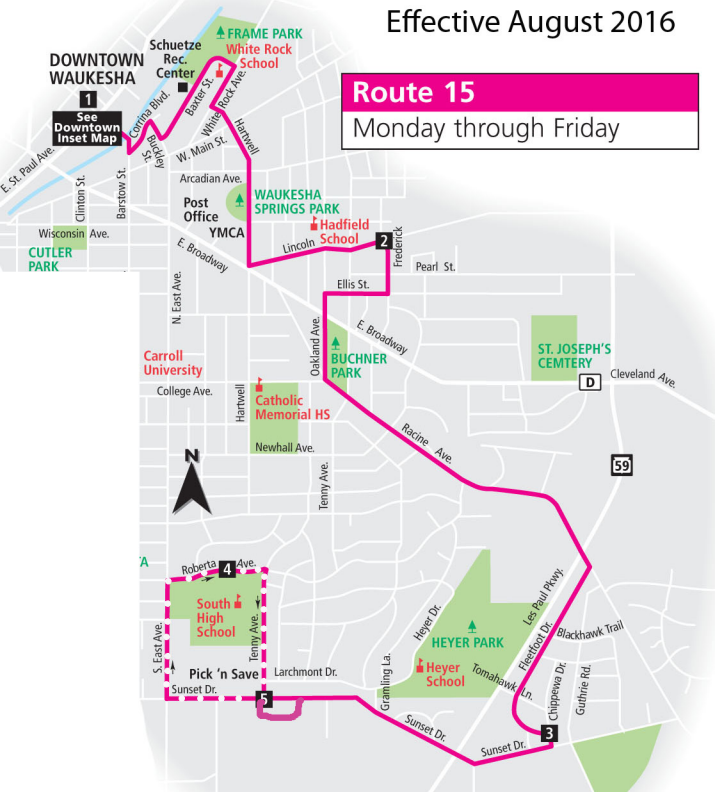
