Laflin Avenue, establish no parking on the north side of Lincoln Avenue from Oakland Avenue to 75' east of Oakland Avenue, establish no parking on the south side of Lincoln Avenue from Oakland Avenue to 125' west of Oakland Avenue, establish no parking on the north side of Lincoln Avenue from Bell Street to 70' east of Bell Street, establish no parking on the south side of Lincoln Avenue from 20' west of Bell Street to 40' east of Bell Street, establish no parking on the south side of Progress Avenue from S. Prairie Avenue to 150' west of S. Prairie Avenue, establish no parking on the south side of E. Broadway from Oakland Avenue to 90' west of Oakland Avenue, establish no parking on the east side of Nike Drive from E. Main Street to 220' south of E. Main Street, and rescind the existing bus stop no parking zone on the south side of Mac Arthur Road west of the Bike Trail be recommended for Council Consent.
