Re: Salem United Methodist Church sign permit variance request

We applied for a sign permit for an LED monument sign for Salem United Methodist Church. The permit was denied because it does not confirm to requirements in Section 27.03 of the sign code. The church is located in zone I-1, which is not within the allowed zones for this type of sign.

We formally request a variance for the following reasons:

- The monument sign will make the church more visible. There is new construction just north of their location, and their building is set back from the road. It blends in with the surroundings and can be easily missed. <u>See photo 1 on page 2.</u>
- An LED reader board on the monument sign allows the church to quickly and easily update messages for their parishioners and general public. The messages may include service dates and times, uplifting messages during times of crisis, devotional messages.
- Salem UMC is competing with other churches in the greater Waukesha area for patronage. Making their facility more visible and modern looking will enhance their image.
- The first Presbyterian Church at the intersection of East Ave and South Street has a similar monument sign with an LED reader board. <u>See photo 2 on page 2.</u>
