*C. Payne will support this application due to loopholes in the newly revised ordinance. Johnson commented that he is opposed to this application, despite the closure of the 10 parking stalls that has been issued for two days, he is against using public property for extensions of premise; he will vote to deny this.*

*Perry is inclined to think the same way. He said if they grant this for House of Guinness, they will have to approve it for any other applicant.*

*Amanda said there were 3 alderman that supported the two day event at the last Council meeting. She said there is flow of traffic through the parking lot. They are an Irish pub and this is a St. Patrick's Day event. They have a good reputation; this is an event that has taken place for many years.*

*Johnson added that most extensions of premise are for private property.*

*Thomas said that they already have the 10 stall closure for 2 days. He said 10 stalls will not solve the parking issue in the downtown.*

*Manion said approval of this for a Saturday is a slippery slope; they would have to approve Saturday extensions to others. He is in support of the event on St. Patrick's Day. He doesn't want to see the parking lot turned into a beer garden. He is inclined to not support the application for dates other than St. Patrick's Day.*

*Thomas is asking for two days. He added that Friday Night Live hurts their business, it doesn't help it.*

**A motion was made by C. Payne, seconded by Jankowski, to approve the Extension of Premise application for March 18th. The motion failed by the following vote:**
