Sec. 6 Fees - The draft reads there is a two tier fee: \$50 for up to 7 block closure and \$150 fee if more than 7 blocks are to be closed; the draft reads the fee would be per closure. Ald. Johnson suggested language to address one application for multiple dates; he agrees with the \$50/\$150 two tier fee. Alty Running suggests that the Downtown District have a special provision to allow for seasonal events.

A motion was made by Chairperson Johnson, seconded by Perry to approve the balance of proposed sec. 6.17 with a provision to include one fee for seasonal events for the B-2 Central Business District to be drafted by the City Attorney's Office; elimination of the notification provision in (12).
