### Subject:

Review and act on the requests from Angie Goodman, Nancy Roberts, Paul Newman, Gene Geiger, Candace Fleming, Dennis Liska, Amina Rodrigues, Julie Kaiser, and Shelina Harvey for one-time sewer credits.

#### Details:

The City of Waukesha Municipal Code Chapter 29 requires sewer billing to be based upon the measured volume of water consumed and allows for a one-time unmetered credit. According to Chapter 29.11(h)(4) titled One-Time Unmetered Credit, users without credit meters may request an adjustment of sewer service charges for special circumstances such as filling of a swimming pool or establishing a new lawn.

 Angle Goodman, 516 Chicago Ave, requested a one-time credit for sewer service charges for June 2024 for filling a swimming pool.

Estimated Additional Usage: 6,133 gallons (2024) @ \$10.48/1000 gal = \$64.27

 Nancy Roberts, 709 Chicago Ave, requested a one-time credit for sewer service charges for July to October 2024 for establishment of a lawn.

Estimated Additional Usage: 8,500 gallons (2024) @ \$10.48/1000 gal = \$89.08

 Paul Newman, 2317 Mac Arthur Rd, requested a one-time credit for sewer service charges for July 2024 for filling a swimming pool.

Estimated Additional Usage: 9692 gallons (2024) @ \$10.48/1000 gal = \$101.57

 Gene Geiger, 1201 Poplar Dr, 1335 Mohican Trail, requested a one-time credit for sewer service charges for June to October for the establishment of a new lawn.

Estimated Additional Usage: 17,050 gallons (2024) @ \$10.48/1000 gal = \$178.68

 Candace Fleming, 1923 Sunnyside Dr, requested a one-time credit for sewer service charges for August to September 2024 for a leaking outside faucet.

Estimated Additional Usage: 76,692 gallons (2024) @ \$10.48/1000 gal = \$803.73

 Dennis Liska, 3819 Valley Creek Dr, requested a one-time credit for sewer service charges for September 2024 for a leaking outside faucet.

Estimated Additional Usage: 27,042 gallons (2024) @ \$10.48/1000 gal = \$283.40

 Amina Rodrigues, 2309 Rickert Dr, requested a one-time credit for sewer service charges for May to July 2024 for a leaking outside faucet.

Estimated Additional Usage: 41,172 gallons (2024) @ \$10.48/1000 gal = \$431.48

• Julie Kaiser, 2303 Bramblewood Ct, requested a one-time credit for sewer service charges for November 2024 for filling a swimming pool.

Estimated Additional Usage: 27,891 gallons (2024) @ \$10.48/1000 gal = \$292.30

• Shelina Harvey, 1028 Cavalier Dr, requested a one-time credit for sewer service charges for June and July 2024 for a leaking outside water pipe.

Estimated Additional Usage: 23,588 gallons (2024) @ \$10.48/1000 gal = \$247.20
