Jurisdictional Transfer Agreement East Sunset Drive City of Waukesha – Town of Waukesha

This Agreement is entered into by and between the City of Waukesha, a Wisconsin municipal corporation, referred to herein as the City; and the Town of Waukesha, referred to herein as the Town. Together, the City and Town are referred to as the Parties.

Recitals

A portion of East Sunset Drive, referred to herein as the Highway, is located within the jurisdiction of the Town. The City desires to make certain improvements to the portion of the Highway located in the Town.

Wis. Stats. §82.03(1) vests management of Town roads in the Town's Board of Supervisors, however, Wis. Stats. §82.03(15) authorizes the Town to enter into a Jurisdictional Transfer Agreement with local units of government containing any terms and conditions that the parties deem necessary regarding the rehabilitation, construction and maintenance of any highway transferred.

The Town is willing to transfer jurisdiction of the section of the Highway currently under its jurisdiction to the City.

Now, therefore, the Parties mutually agree to transfer jurisdictional responsibility for the Highway according to the following terms:

- The Town transfers jurisdiction of that section of East Sunset Drive, including all right of way, from a line west of Camden Way to the City boundary line west of Sunset View, as shown on the attached Exhibit A and as moreparticularly described in the attached Exhibit B.
- 2. The City accepts jurisdiction of that portion of the Highway described in section 1, above.
- 3. The City agrees that it, or a developer that has entered into an agreement with the City, shall assume all costs related to the periodic maintenance and reconstruction of the above-described section of the Highway, including but not limited to the driving surface, curb and gutter, storm water collection, snow and ice control, traffic engineering, signs, signals and pavement markings related to the Highway.
- 4. The Town acknowledges that the City intends to reconstruct or improve East Sunset Drive from a two-lane urban highway to a four-lane urban highway. The City, or a developer that has entered into an agreement with the City, shall be responsible for obtaining all permits required for the contemplated reconstruction or improvement of the Highway.
- 5. The City shall be responsible for all traffic control and enforcement of the transferred portion of the Highway.

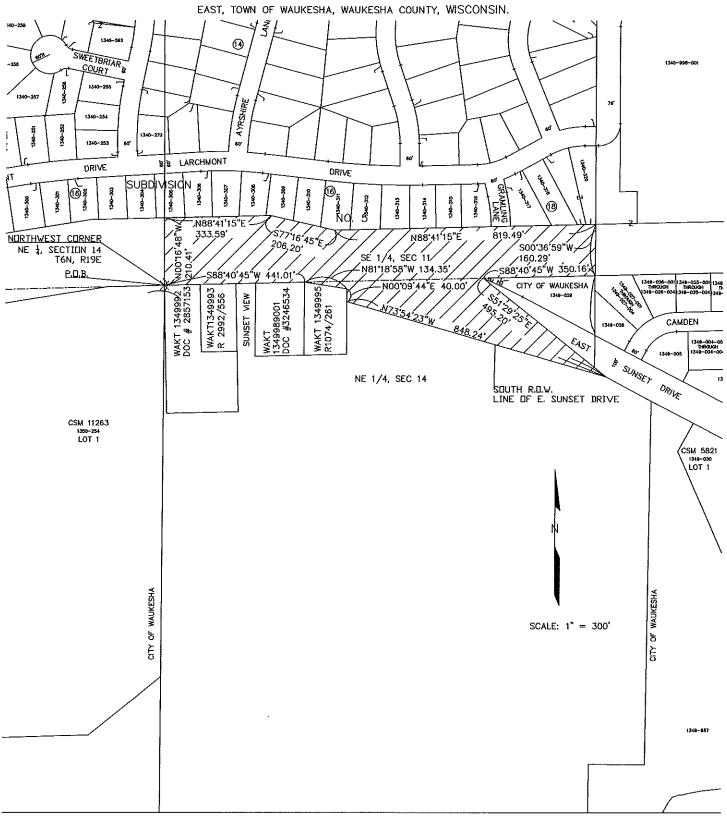
