Dear Property Owner(s):

This is the fourth notice regarding violations at your above property. Previous notices were sent on July 19<sup>th</sup>, 2023, August 10<sup>th</sup>, 2023, and October 10<sup>th</sup>, 2023. During a recent inspection, the following violations were found to remain:

**28.05(3)(a)** Certificate Required. No owner or person in charge of a historic structure, historic site, or structure within a Historic District shall reconstruct, alter or demolish all or any part of the exterior of such property or construct any improvement unless a Certificate of Appropriateness has been granted by the Landmarks Commission.

408-412 McCall St. is located within the McCall Street Historic District. Any exterior work on the house must be approved by the Landmarks Commission before work begins. The Landmarks Commission review is intended to maintain the historic character of the property and of the neighborhood in general.

A window on the west side of the main building has been replaced. Some siding has been removed as well, and it appears that you are in the process of replacing it. You will need to submit an application for a Landmarks Commission Certificate of Appropriateness for the already completed and already started work. If any work has been done in such a way that it does not meet the standards for a Certificate of Appropriateness you will need to fix it at your expense.

Each and every day the violation continues is considered to be a separate offense. The August 10<sup>th</sup> notice included a citation for one offense. The October 10<sup>th</sup> notice included citations for seven offenses, dated September 1<sup>st</sup> through September 7<sup>th</sup>, 2023. Enclosed with this letter you will find a citation for the offenses dated September 8<sup>th</sup>, 2023 – September 28<sup>th</sup>, 2023. Citation amounts are \$187.00 per offense, and this citation includes twenty-one offenses for \$3,927.00 total. Daily citations will continue until you address the violation. Continued failure to respond may result in additional action such as a lawsuit.
