3. Discussion and Recommendation re:

A. [ID#15-3143](#) Install a crosswalk on East Ave. from South St. to east side of East Ave. including curb cuts when South St. is rebuilt.

Recommendation: This item has come up twice in the past, once in 2013 and another time in 2014. In 2013, the committee denied installing a crosswalk at this location. In 2014, a similar request was made and denied again. Staff has not changed its position on this issue. South Street, in this location, is not scheduled for reconstruction nor is it scheduled in the next 5 year plan. Staff recommends no action on this item.

B. [ID#15-3144](#) Approve a speed awareness campaign to allow residents to place yard type signs in the terrace area on Madison St. from Moreland Blvd. to North St. starting August 29, 2015 and concluding on September 12, 2015 .

Recommendation: Staff has reviewed this request by the Tower Hill Neighborhood group to install "slow down" speed awareness signs in the terrace on Madison Street. This group has conducted similar campaigns in 2014 and in May 2015. Staff recommends approval of the campaign in September 2015 subject to the following conditions:

The Tower Hill Group will be responsible for placement of the signs in the terrace and removal of the signs after the two week period.

The group should also insure that the signs are not given to others that are not in the Tower Hill area as to keep the signs from popping up all over the City. The group may keep the signs displayed on their private property behind the sidewalk.

The group shall conduct all activity safely and in coordination with the City police department.

Recommended Motion: Move to approve a speed awareness campaign to allow yard type signs in the terrace area on Madison St. from Moreland Blvd. to North St. starting August 29, 2015 and concluding on September 12, 2015..

- C. [ID#15-3145](#) Approve the conversion of Carroll Street from a one way street to a two way street from Maple Avenue to N. Barstow Street

Recommendation: This item was brought forward to the Buildings & Grounds committee through the Public Works department and with endorsement from Ald. Patton. Carroll Street has been temporarily converted from a One Way street to a Two Way street during the reconstruction work on Maple Avenue. During this time, we have received positive comments about Carroll being a two way street again. Carroll Street has been one way from Maple to Grand Ave since 1957. In 1972, Carroll from Grand to East Avenue was converted to a one way street. Current land uses, lower enrollment with Les Paul school and the larger library foot print are reasons to have the street converted back to a two way street for better traffic flow. A two way street would be more efficient for traffic flow. The School District and Les Paul school are OK with two way, the Library is very supportive, St. Luke's church was supportive of it, the police department and Ald. Patton both endorsed changing it back to two way. Staff recommends approval to convert Carroll Street from a one way street to a two way street.

Recommended Motion: Move to approve the conversion of Carroll Street from a One-Way street to a Two-Way street from Maple Avenue to N. Barstow Street.
