## RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolution was approved at the February 18, 2019, Building and Grounds meeting and brought forward to the March 5, 2019, Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

ID#19-0152 Install the flashing pedestrian crossing signs on W. Moreland Blvd. at Airport Road. Said flashing signs to be funded and installed with the W. Moreland Blvd. Resurfacing project in 2019.

ID#19-0154 Establish No Parking Any Time on the north side of Summit Avenue at the following locations:

- From 625 feet west of centerline of N. University Avenue to 40 feet east of centerline of Brentwood Drive
- From 50 feet west of centerline of Briar Hill Drive to 70 feet east of centerline of Western Avenue
- From 190 feet west of centerline of and up to N. Grandview Blvd.

ID#19-0155 Establish No Parking Any Time on the south side of Summit Avenue at the following locations:

- From 625 feet west to 150 feet east of centerline of N. University Drive
- From 320 feet east of centerline of N. University Avenue to west lot line of 2407 Summit Avenue
- From east lot line of 2301 Summit Avenue to 50 feet east of the centerline of Greenmeadow Drive (south leg)
- From 100 feet west of and to the centerline of Western Avenue
- From 500 feet west of centerline of and up to N. Grandview Blvd.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in their office as part of the original City records.
