RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the March 5, 2018, Buildings & Grounds meeting and brought forward to the March 20, 2018, Common Council Meeting for approval under the Consent Agenda.

- ID #18-0283 Establish 3 Hour Parking, 7:00 am to 7:00 pm, Except with Permit for all stalls in Municipal Lot 6. Previously designated 30 minute parking stalls on the northwest corner shall remain unchanged.
- ID #18-0284 Rescind previous parking resolution dated 4/5/89 for Municipal Lot 8 only. Previous resolution reads "Establish 3 hour parking, Except Sunday, Except by Permit".

- ID #18-0285 Establish 3 Hour Parking, 7:00 am to 7:00 pm, Except with Permit for all stalls in Municipal Lot 8. Previously designated stalls described in ID#16-0730 dated May 17, 2016 shall remain unchanged.
- ID #18-0286 Rescind previous 2/16/83 resolution that establishes Municipal Lot 9 as one-way traffic flow. Municipal Lot 9 will revert back to two-way traffic flow.
- ID #18-0287 Establish two handicap parking stalls in Municipal Lot 9. Two stalls will be located in the northwest most corner of the lot.
- ID #18-0288 Establish No Parking, 2:00 am to 5:00 am Except with Permit for all parking stalls on the west side of Municipal Lot 9 excluding the two handicap parking stalls.
- ID #18-0289 Establish 3 Hour Parking, 7:00 am to 7:00 pm, Except with Permit for all stalls in Municipal Lot 11. Previously designated three - 15 minute parking stalls at the north end of the east row by library shall remain unchanged.
- ID #18-0290 Modify the existing parking designation of "Permit Parking Only, 6:00 am to 4:00 pm" to be for Monday to Friday only for said designated stalls in Municipal Lot 12.
- ID #18-0292 Establish 3 Hour Parking, 7:00 am to 7:00 pm on Saturdays, Sundays and Holidays for all stalls in Municipal Lot 12 excluding those designated for city maintenance vehicles.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in their office as part of the original City records.
