## RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolution was approved at the October 15, 2018, Building & Grounds meeting and brought forward to the November 8, 2018, Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

ID#18-1498      Install a stop sign on southbound Mountain Ave. at Motor Ave.. Install an advisory sign below stating, "Traffic From Left Does Not Stop".

ID#18-1499      Install an advisory sign stating, "Traffic From Right Does Not Stop" and mount below the existing stop sign on eastbound Motor Ave. at Mountain Ave..

ID#18-1500      Rescind the following parking zones on the west side of Walton Ave. at various locations from W. College Ave. to W. Newhall Ave.:  
A - No Parking, 7:30am to 4:00pm, Except Saturdays, Sundays and Holiday  
B - No Parking, Bus Loading Zone  
C - No Parking, 8:30am to 3:00pm

ID#18-1501      Approve installation of No Parking Stopping or Waiting on the east and west sides of Walton Ave. from 35 feet north of south property line of 129 Walton Ave. to the south property line of 117 Walton Ave..

ID#18-1528      Approve installation of a WE Energies street light on an existing power pole near 2011 Sunkist Ave..

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in their office as part of the original City records.
