## Ordinance No. -18

## An Ordinance Amending Section 25.08 of the Waukesha Municipal Code, Regarding the Authority of Community Service Officers to Issue Citations

The Common Council of the City of Waukesha do ordain as follows:

Section 1. Waukesha Municipal Code §25.08 is amended to read in its entirety as follows:

## 25.08 Form of Citations, Authority to Issue.

- (1) Adoption of Citation Form. The forms of citation described in Wis. Stats. §800.02(2)(a), §800.02(2)(ag), and §800.02(2)(b) are adopted and authorized for use for violations of the Municipal Code.
- (2) Authority to Issue. Citations may be issued by any of the following persons, for the specified violations:
  - (a) Police Officers. Sworn police officers may issue citations for any violations of the Municipal Code.
  - **(b)** Community Service Officers. Civilian Community Service Officers may issue citations for violations of the following Municipal Code Sections:
