## Subject:

Review and act on hiring GRAEF for the 2015 Construction Inspection Services.

#### Details:

The City of Waukesha Department of Public Works solicited for proposals for a Consultant to provide construction inspection services on 2015 construction projects. See the request for proposals issued February 13, 2015 attached. This request was responded to by 4 consultants and the City's review committee chose GRAEF for the work. See the attached memo with this recommendation and rankings of the Consultants. GRAEF's proposal dated February 27, 2015(Attached) includes the hourly fee schedule for labor and expenses. GRAEF will supply an inspector classified for a Moderately Complex project for the Maple Avenue Utility and Street Improvements Project and an inspector classified for a Complex project for the Summit Avenue / Delafield Street Utility and Street Improvements Project (Phase 1).

The total expense for the inspection work on these two projects is \$153,300. This total breaks down between the two projects as shown below:

Project Inspection Services Cost Estimate

Maple Avenue \$67,050 Summit Avenue / Delafield Street \$86,250

### **Options & Alternatives:**

Another one of the Consultants could be chosen, but GRAEF is recommended due to their experience and expertise along with the cost considerations.
