*Chief Jack spoke regarding the alcohol compliance checks that were completed by his department in 2018. There were 24 failures of the 117 establishments that were checked, for a failure rate of 20.5%. This is up from a 12% failure rate for 2017. The Committee will be inviting the establishments that failed their check to appear at a meeting in March with their plan of action to prevent the sale of alcohol to a minor in the future. Chief Jack will give the Committee a four year history of any other violations for the 24 establishments that failed at their next meeting.*
