6. Matter of Report

Director Damien provided an update on the 2024 leaf collection. Joe Baginski City Garage Supervisor managed the project and was present for questions. The view of the collection was that it was a success. 5,434 tons of leaves were collected. Roughly the same amount of leaves as in previous years with 14 less days. Staff used GIS mapping to identify routes for staff and residents. Crews were able to complete more work doing other things as well. The financial impact was 1,982 fewer labor hours which equated to \$119,000 in savings. \$15,338 of fuel savings and \$6,000 skid steer rental savings. Overall a total of \$140,000 in savings. A main concern from residents was the reduction of pickups from three to two. Also, the mapping of 4+ days was confusing because they didn't understand the time to get around the city. Staff will consider a number of changes for next year and start somewhere where the leaves fall earlier. Staff is contemplating picking up leaves and brush in the spring to help the residents this year. The goal will be to keep the start date of collection as late as possible but not go into early December due to the snow. Ald. Payne commented that he was glad we had only 2 pick ups and he only had a few complaints. He thanked the crews.
