<b>Subject:</b> Approve No Parking This Side of Street on the east side of Maple Avenue from Wisconsin Avenue to W. Main Street (revised to be No Parking Any Time from Wisconsin Ave to W. Main Street and to allow 2 Hour Parking, 7AM to 7PM, Except Sundays and Holidays between the parking lot driveways for Couri Insurance)	

**Details:**  
This item was brought forward by Engineering and endorsed by Ald. Helgestad. Maple Avenue from Wisconsin to W. Main Street has undergone many parking changes through the years. The east side of Maple Ave has always been signed No Parking but some signs missing or not reinstalled since street was reconstructed. When researching the history of parking resolutions, no clear resolution was found to establish No Parking on the east side of Maple Street. This item is to clarify that No Parking is desired on the east side of Maple Avenue and to have a resolution to enforce it.

The B&G Committee reviewed this item and determined that allowing parking on the east side of Maple Street is desired. Ald. Cummings moved that the item be revised to allow 2 Hour Parking, 7AM – 7PM, Except Sundays and Holidays between the two driveways that serve the Couri Insurance parking lot. Engineering staff estimated that this would fit about two vehicles. Staff also recommended that the remainder of the east side of Maple Avenue be designated at No Parking Any Time. The committee agreed to the parking allowance and the No Parking designation. By motion, item ID#18-0685 was revised to be “No Parking Any Time from Wisconsin Ave to W. Main Street and to allow 2 Hour Parking, 7AM to 7PM, Except Sundays and Holidays between the parking lot driveways for Couri Insurance”.

This revised item passed with unanimous consent.
