## RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the September 14, 2015 Buildings & Grounds meeting and brought forward to the October 6, 2015 Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#15-3349      Install Autistic Child Area signs on Victoria Drive 150 feet east and west of 1527 Victoria Drive.
- ID#15-3350      Move the crossing guard from the intersection at Madison Street & N. Moreland Blvd. to the intersection at S. Charles Street & E. Laflin Avenue
- ID#15-3351      Install No Parking Any Time on the north side of W. St. Paul Avenue from 140 feet east of N. Prairie Avenue to the corner of Fairview Avenue.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
