## RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the January 5, 2015 Buildings & Grounds meeting and brought forward to the January 20, 2015 Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#14-1493      Approve the Waukesha Downtown Business Association to close Municipal Parking Lot 1 for the Farmers Market every Saturday May 2, 2015 to October 31, 2015 from 5:00 a.m. to 2:00 pm. This closing would include permission to tow vehicles from the area.
- ID#14-1685      Approve the House of Guinness to close a portion of Municipal Parking Lot 3 on March 17, 2015 for an event. The House of Guinness will be required to do the following:
  1. Reserve any needed barricades with the City Garage (524-3516)
  2. Pickup, setup, dismantle and return barricades to the City Garage by March 19, 2014.
  3. Post "No Parking March 17" in any stalls to be occupied in advance of the event. Obtain cardboard signs from the Police Department.
- ID#14-1728      Approve the installation of three No Dumping signs on the south side Pearl Street from the east property line of 1345 to the west property line of 1401 Pearl Street.
- ID#14-1740      Approve the installation of a stop sign on westbound Portage Trail at Stillwater Circle.
- ID#14-1741      Approve the installation of a stop sign on eastbound Portage Trail at River Valley Road.
- ID#14-1742      Approve the installation of a stop sign on eastbound Tanglewood Drive at Rivers Crossing Drive.
- ID#14-1743      Approve the installation of a stop sign in northbound Bayberry Drive at Stillwater Circle.
