#### RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the February 2, 2015 Buildings & Grounds meeting and brought forward to the February 19, 2015 Common Council Meeting for approval under the Consent Agenda.

ID#14-1877	Rescind existing No Parking zone on the east side Maple Avenue from W. College Avenue to 150 feet north.
ID#14-1888	Establish No Parking Any Time on the east side Maple Avenue from W. College Avenue to 200 feet north.
ID#14-1889	Establish No Parking Any Time on the west side Maple Avenue from W. College Avenue to Dunbar Avenue.
ID#14-1890	Rescind existing No Parking 8:30 to 3:00 on the east side of Maple Avenue from 150 feet south to 50 feet north of Carroll Street.
ID#14-1891	Establish No Parking Any Time on the east side of Maple Avenue from 60 feet south of the Wisconsin Central Rail Road tracks to Wisconsin Avenue.
