RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolution was approved at the May 14, 2018, Building and Grounds Committee meeting and brought forward to the June 5, 2018, Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

ID#18-0684 Install cross walk markings on the north and west legs of the intersection of Rempe Drive and Penhurst Way. Install crosswalk warning signs on the north leg of intersection.

ID#18-0686 Adjust the no parking zone in front of the house at 476 NW Barstow. Move the No Parking sign from the power pole to the south side of the Driveway of 476 NW Barstow. (item was amended at B&G committee to have ID#17-0502 rescinded instead which is to remove the entire No Parking zone).

ID#18-0687 Install 25 MPH speed limit signs on Fiddlers Creek from Meadowbrook Road to Madison Street

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in their office as part of the original City records.
