*Fuzzy's Pub & Grill - Phil Santiago appeared. A bartender sold alcohol to an underage person during a compliance check. His employee called him and informed him right away. He was written up; he is still employed. Santiago said that he talks to his employees everyday about the importance of carding patrons.*

*Grand Ave. Hometown - Sukhjit Singh appeared. His employee sold to an underage person during a compliance check. His employees are instructed to card patrons that appear under 35 years old. It was recommended to him by the Committee that they card all patrons.*

*Let's Roll Tobacco & Liquor - Sarah Cramer, Tracy Hinski, Paul (co-owner) appeared. The person that sold to an underage person during a compliance check no longer works for them. The employee did tell them right away when it happened. They do not allow underage patrons in the store. They have mandatory monthly meetings, as well as shift change meetings.*
