**Assessment**

After cleaning, re-assess roof system and components to determine if any specialty repairs or physical replacement of any elements is needed in order to properly prepare roof for application of the Cericade Roof System.

NOTE: No physical replacement of any roof elements is included in this scope of work, unless specifically noted in this contract, therefore any items requiring replacement would be done at an additional cost.

**Flashings Reconditioning**

All roof penetrations and transitions to be inspected and re-conditioned prior to installation of new Cericade roof system.

Note: Re-conditioning is defined as re-sealing, caulking, or coating the exiting flashing components and is not a physical replacement of the flashings.

**Cericade Application**

Multi-layer application of the Cericade roof system. System to be installed with 1 vertical pass with approximately 50% overlap and 1 horizontal pass with approximately 50% overlap to create a "web like" application for proper coverage.
