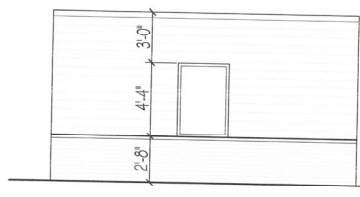

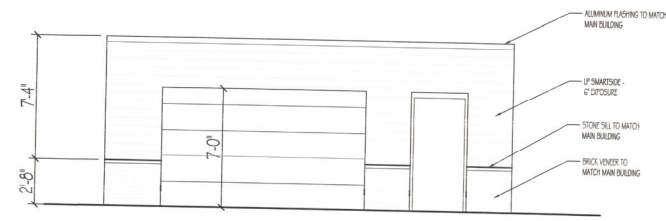
EAST ELEVATION

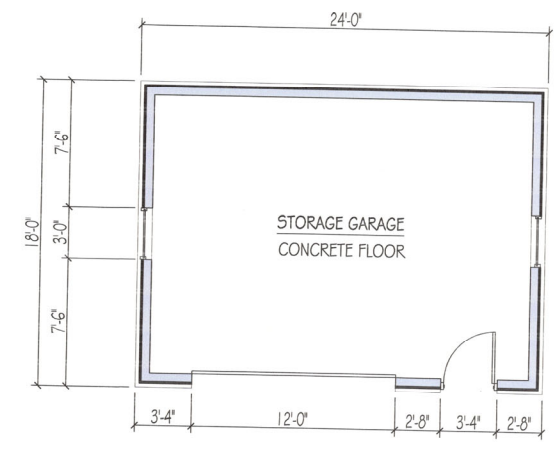
NORTH ELEVATION
