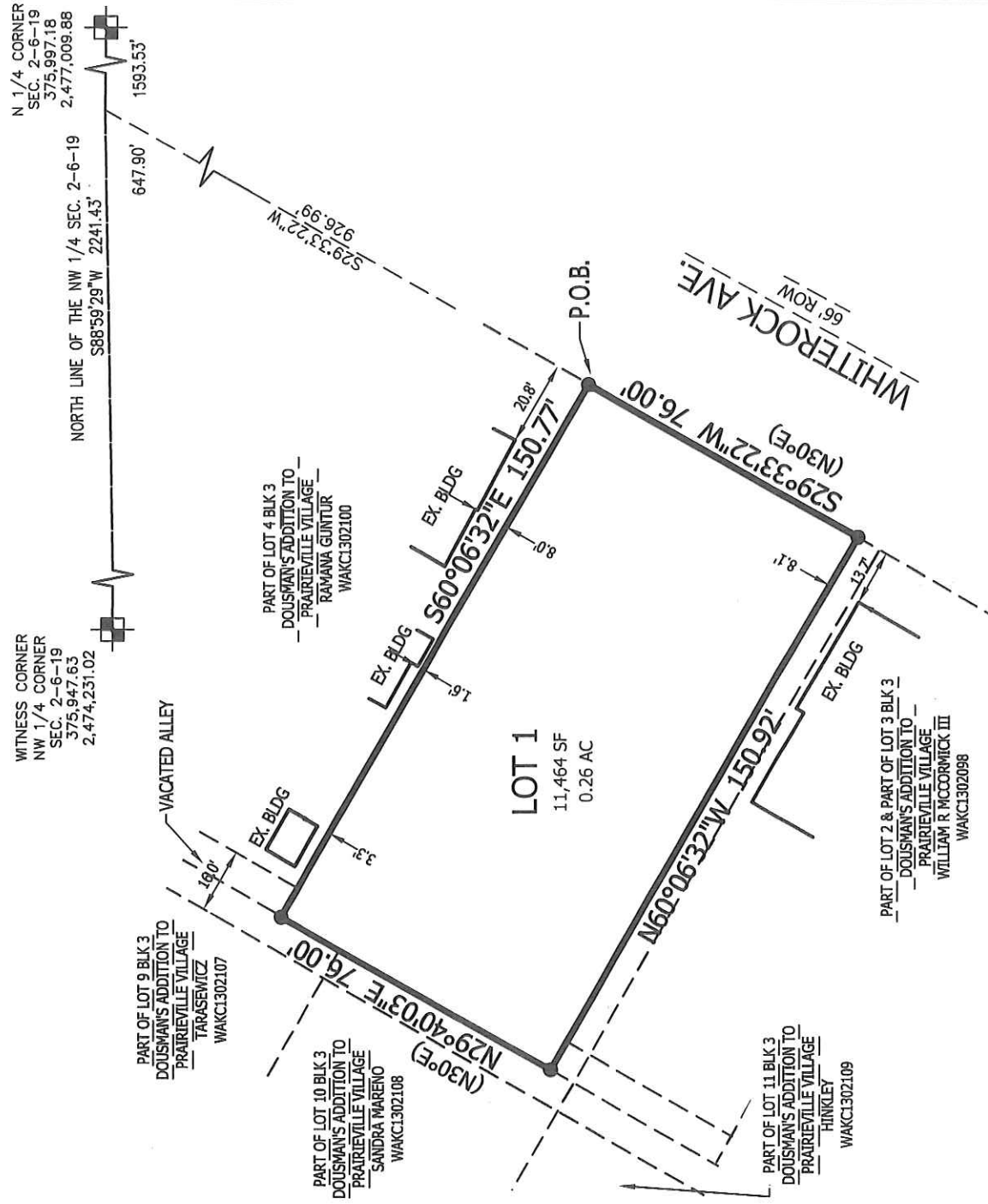

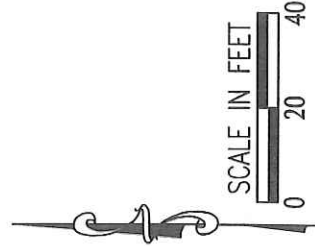
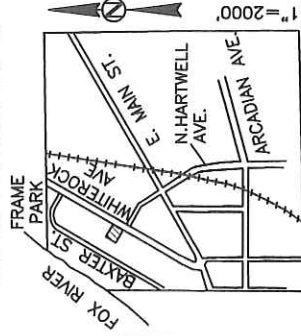

That I have surveyed, and mapped a of part of being a of part of Lot 3 and 4, Block 3, and the vacated alley of Dousman's Addition to Prairieville Village, and a part of the NW 1/4 of the NW 1/4 of Section 2, T.6N. R.19E. City of Waukesha, Waukesha County, Wisconsin, more fully described as follows:

Commencing at the North 1/4 corner of Section 2, thence South 88°59'29" West, along the North line of the Northwest 1/4 of said Section 2, a distance of 1593.53 feet; thence South 29°33'22" West, along the Northwest right-of-way of Whiterock Avenue, a distance of 926.99 feet to the point of beginning of lands to be described;

Thence continuing South 29°33'22" West, along said right-of-way, a distance of 76.00 feet; thence North 60°06'32" West, 150.92 feet; thence North 29°40'03" East, 76.00 feet; thence South 60°06'32" East, 150.77 feet to the point of beginning.

Said lands contain 11.464 square feet or 0.26 acres.


