RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- \*\*3c. Installation of stop signs on eastbound and westbound Springbrook North at the intersection with Penhurst Way and the installation of supplemental signs that say "All Way" under all four stop signs at the intersection. (Unanimous)
\*\*3d. Installation of a stop sign at the northbound approach of Penhurst Way at the intersection with Springbrook South and install supplemental signs that say "All Way" under all four stop signs at the intersection. (Unanimous)
\*\*3e. Establish a No Parking zone on the east side of N. Hartwell Avenue from the intersection of E. Broadway to the north property line of 333 N. Hartwell Ave. (Unanimous)

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
