Director Damien gave an update on the Residential Solid Waste proposals. The City received 6 proposals which is considered very competitive: Johns Disposal, Waste Management, Pelletteri, GFL, LRS, and Harters all provided good quality proposals. The City will be moving forward with interviewing and negotiating with the top three candidates. The reviews will be done by the City Administrator, Finance Director, Director of Public Works and Residential and Solid Waste Manager. The goal is to finish that process and come back to the Board for a recommendation in June. RFP required alternatives and potential for new carts and purchasing existing carts and bulky item services.
