Police Department

Public Works

• The Department is working on 2024 projects. You can view an interactive project map on the City website. When you click on the page you can see weekly updates for the project.

Clean Water Plant

- Continuing working on five-year Wastewater Discharge Permit application due July 2024.
- Received the DNR lab audit results and are working on changing lab SOPs to meet new standards.
- Took a tour of Milwaukee Jones Island biosolids facility in preparation for the dryer upgrade.
- Met with the DNR to discuss permitting for the dryer upgrade.

Transit

- WisGo Update-Passengers can now purchase and re-load WisGo Cards at the two Waukesha Pick-n-Save and one Metro Market stores. Additional re-load locations are expected to be announced in the near future. Staff is also working on plans to add Metrolift to WisGo.
- Staff is finishing up work related to service changes taking effect June 17th that includes changes to service for the 2024-25 school year. Flyers were handed out on the student routes about the changes that will take effect next school year the week of May 27th. Staff is also working on potential future changes based on potential changes to key destinations.
- 2024 CIP projects Update:
 - The New Driver Relief van is complete.
 - Design work on the Badger Drive remodel is has been completed and ready for the bidding process.
 - Badger Drive fence project is in the planning stage.
 - o Purchase orders for bus engines and transmissions have been sent out.
 - Planning for AC condenser project is near complete.
- The contract for Transit Tire Leasing with Goodyear for the next 5 years has been approved and executed. The new agreement will go through 9/30/29.
- Transit staff is finishing a bus shelter plan to guide Transit on what parameters Transit should analyze to determine where bus shelters should be located and will present to the Transit Commission for approval.
