The access easement note shown on the Survey is for 100 Arcadian to cross 110 Arcadian but not for 110 Arcadian to cross 100 Arcadian Ave.
- 4. The lot lines shown on the Survey don't appear to align with City GIS records so it is difficult to determine if a 10 foot wide strip exists along the east side of the lot for access to rear of lot. A current Property Survey of 110 Arcadian Avenue should be prepared and submitted. Provide Property Survey in accordance with A-E 7 Minimum Standards for Property Surveys.

- 6. Where will the snow storage be located for the parking lot?
- 7. Will there be an ADA parking stall? Will parking stalls be marked? Is a garbage dumpster location needed?
