All that part of Block B and Block D, and Vacated Harvey Avenue of Laflin's Second Addition to the Village of Waukesha, together with the south ½ of the vacated Alley abutting on the north of the North ½ of the vacated Street abutting on the south, and part of Pine Grove Subdivison of Lot 14, together with the South ½ of the vacated Alley abutting on the north and the vacated Jackson Street, and all of the vacated Railway Avenue on the west, being part of the Northwest Quarter (NW ¾) of the Northeast Quarter (NE ¾) of Section Ten (10), in Township Six (6) North, Range Nineteen (19) East, in the City of Waukesha, Waukesha County, Wisconsin. Basic Description:

Carroll University seeks to combine all of the small lots that make up Haertl Field into one parcel commensurate with the existing land use. The combination the small parcels that make up this property into one parcel via certified survey map was a condition for the approval of this project.
