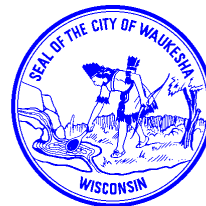

## RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolution was approved at the May 6, 2019, Building and Grounds meeting and brought forward to the May 21, 2019, Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#19-0593 Install No Parking on north side of Gascoigne Drive from the centerline of Peters Drive to 125 feet east.
- ID#19-0594 Propose parking zone on the south side of Summit Avenue to be No Parking Any Time from east lot line of 2301 Summit Avenue to 415 feet east of the centerline of Greenmeadow Drive (south leg).
- ID#19-0596 Remove No Parking signs on the northbound and southbound approaches of S. Grandview Blvd. at Napa Trail.
- ID#19-0597 Remove No Parking signs on the northbound and southbound approaches of S. Grandview Blvd. at Howard Street.
- ID#19-0598 Remove No Parking signs on the westbound approach of Cambridge Avenue to Yvonne Street.
- ID#19-0599 Approve No Parking Any Time on north side of Abbott Drive from centerline of Parklawn Drive to 180 feet east.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in their office as part of the original City records.
