Ordinance 6.17 - Street Closures

Manion still supports a 45 day application minimum before an event. He feels there are options in our ordinances for people to organize with short notice. He is not in favor of a small 7 day window for someone to object to an event. Manion asked if an applicant could be charged more for an application that is filed with short notice.

Payne supports changing the minimum days to apply for a street closure to 30 days.

Revised draft to come back to Committee. See motion for details.

Johnson moves to approve an amendment that street closure applications be filed no less than 30 days from the event; a \$50 fee to be added to any application filed less than 45 days. Motion seconded by Payne.

Manion would like to see the 14 day period for objection to an application restored to the draft. Manion made a friendly amendment to the motion to amend (13)(a)(iii) from 7 days to 14 days; in (v) change 20 days to 24 days. Friendly amendment accepted by mover and seconder. Motion passed unanimously.

Ordinance 6.18 - Special Events

Changes will be made reflecting the amendments made to the street closure ordinance; in (5) change 25 days to 30 days; in (12)(a)(iii) change 20 days to 24 days.

Manion would like to see the B-2 district fee raised from \$150 back to \$350 as in the previous draft. Jankowski would support this change.

Johnson is in favor of the proposed changes, with the exception of the fee increase to \$350.

Manion made a motion to approve 6.18 with the following amendments: (5) change 25 days to 30 days; (6)(e) change the B-2 Central Business District fee from \$150 to \$350; adding something in (6) that involves permits being filed less than 45 days to have an additional \$50 added to all categories; (12)(a)(iii) from 20 days to 24 days. Motion seconded by Jankowski.

C. Payne made friendly amendment limiting applicants to 30 events annually; Manion and Jankowski agreed.
