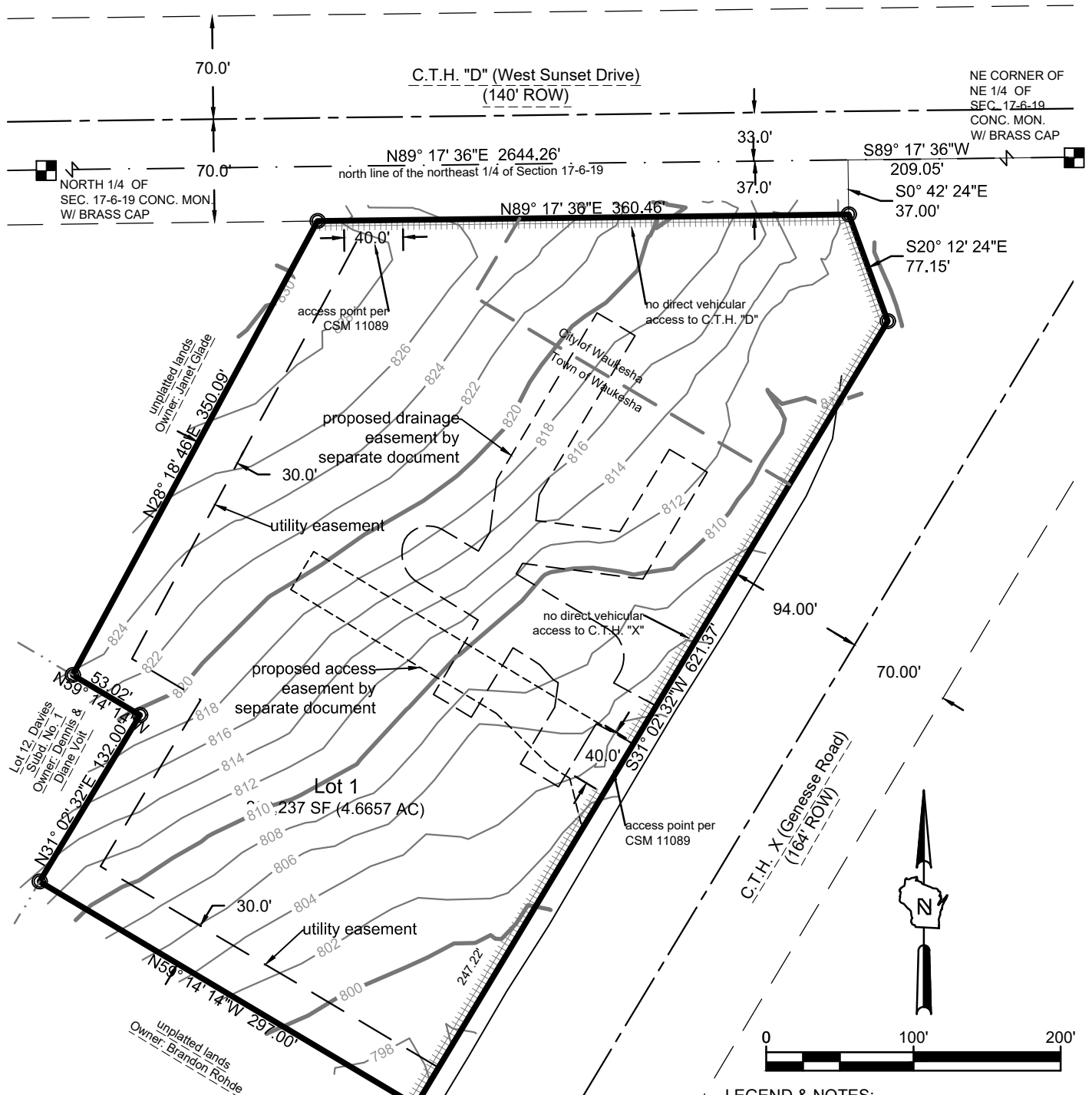


# CERTIFIED SURVEY MAP NO.
