RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- **3c. Place a warning sign for an Autistic Child on the north and south sides of the street in the 300 block of Baird Street.
- **3e. Establish No Parking on the south side of Dopp Street 70 feet east and 70 feet west of the corners of Dopp Street and Greenwood Avenue.
- **3f. Install a Handicap Parking sign on the south side of Morey Street in front of 327 Morey Street.
- **3g. Install No Parking Any Time on the north side of Chicago Avenue from the west property line of 820 Chicago Avenue to the corner of Hyde Park Avenue.
- **3h. Install No Parking Any Time on south side of Chicago Avenue from 30 feet west to 30 feet east of the corners of Hyde Park Avenue.
