*Patton would like the ordinance to state 1.5 car spaces vs. 2 car spaces per apartment. He believes this is a roadblock for development on small parcels. He said it is proven that we don't need 2 car spaces; less parking has been approved for developments at 1 5/8 spaces per apartment. Perry said we don't always follow what we have in the code, we do vary from it. He said if we are going to have a guideline, he would rather have it higher and then amend it down when appropriate. He also suggested conferring with the Plan Commission. Johnson said this is on an upcoming Plan Commission agenda. Johnson suggested putting this on hold until the Plan Commission reviews the request, as they are the ones that use this criteria. Patton said the downtown would benefit from this change. Patton said there are 1800 parking spaces downtown.*
