## 2015 Federal Transit Funding Assistance for the City of Waukesha and Waukesha County

A public hearing has been scheduled by the City of Waukesha Transit Commission for Thursday, September 17, 2014 at 5:30pm in the City of Waukesha Common Council Chambers, City Hall, 201 Delafield Street, Waukesha, for the purpose of considering transit projects for which urbanized area federal funding assistance, pursuant to Section 5307 of the Federal Transit Act of 1964 as amended, is being sought, generally described as follows:

The amount of federal section 5307 capital funding assistance available to the Milwaukee urbanized area: 2015 allocation: \$19,899,567.00.

## Section 5307 projects for City of Waukesha:

- 1. Capital cost of vehicle maintenance Cost: \$550,926 Federal share: \$440,741
- 2. Tire Lease: Cost: \$36,000 Federal share: \$28,800
- 3. Associated Transit Improvements: Cost: \$5,929 Federal share: \$4,743

Total estimated costs: \$592,855 Total federal share: \$474,284

The local share of capital costs will be provided by the City of Waukesha. The proposed projects are for use by the publicly-owned transit system operating in the City of Waukesha.

## Section 5307 projects for Waukesha County:

- 1. Capital cost of 3<sup>rd</sup> party contracting. Cost: \$586,926 Federal share: \$469,541
- 2. Associated Transit Improvements: Cost: \$5,929 Federal share: \$4,743

Total estimated costs: \$592,855 Total federal share: \$474,284

The local share of capital costs will be provided by Waukesha County. The proposed projects are for use by the publicly-owned transit system operating in Waukesha County.

None of the scheduled projects will involve acquisition of property or relocation efforts. The proposed projects will not have a significant environmental impact upon the transit service area. The projects are in conformance with comprehensive land use and transportation planning in the Milwaukee urbanized area, and are consistent with the programming of projects in the *Transportation Improvement Program for the Milwaukee Urbanized Area, 2013-2016.* 

At the hearing, the Waukesha Transit Commission Board will afford an opportunity for interested persons or agencies to be heard with respect to the social, economic, and environmental aspects of the proposed projects.
