## RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- \*\*3c. a. Establish a 5 Ton trucking weight restriction on Guthrie Road from E. Sunset Drive to County Hwy Y (Racine Avenue).
- b. Rescind existing 3 Ton trucking weight restriction on E. Sunset Drive from STH 59 / 164 (Les Paul Parkway) to Guthrie Road.
- \*\*3d. Approved - Allow Hadfield Elementary School to restrict westbound traffic on Linden Street from Bell Street to Oakland Avenue, on school days, between 3:00 to 4:00 pm.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
