W St Paul Avenue (300' East of Mountain Avenue to Mountain Avenue)

- On W St Paul Avenue on the north side of the road, existing parking allowed from 300' east of Mountain Avenue to Mountain Avenue

W St Paul Avenue (Wisconsin/North to Fuller Street)

- On W St Paul Avenue on the south side of the road, existing no parking from 450' east of Wisconsin to Fuller Street
- On W St Paul Avenue on the north side of the road, existing parking from North Street to 450' east of North Street
- On W St Paul Avenue on the north side of the road, existing no parking from 575' east of North Street to Fuller Street.
