*Kassandra Johnson appeared with Mary Jaquith, manager of Speedway - Sunset. Johnson's background check includes several underage drinking convictions (3), minor transporting intoxicants in motor vehicle (2), possession of synthetic cannabinoid (5/15), possession of controlled substance (3/15). K. Johnson said she was hanging around the wrong people when a lot of things things happened. She is trying to make better decisions. If she doesn't get the bartender license she won't be able to work as many hours and she won't be able to support herself. Jaquith said Johnson is an excellent employee. Perry said she has 9 offenses involving alcohol or drugs between 2011 and 2015, this is beyond the threshold. Johnson has worked for Speedway for 5 - 6 months. Manion asked what changes she has made in her life; Johnson said she has eliminated people from her life; she is working and not going out as much as she used to; she is trying to make better choices. Johnson said he can't approve this license due to the volume of violations. He would need to see a longer period of time with no violations.*

*Dallas Kinski appeared with Paul Leofilus, co-owner of Let's Roll Tobacco; Kinski is his nephew. He has several underage drinking violation; OWI in 2014. Leofilus would like to get Kinski into a more leadership position at the store. Perry said there is a pattern here. Perry said his record is beyond the threshold for a denial. Kinski said he has learned from his first and only OWI; he has worked to build himself back up; he has worked under his uncle in the store and cards every customer. Kinski worked for Let's Roll off and on for a total of 2 years. Leofilus has seen Kinski refuse to sell to customers because they were already intoxicated. Sgt. Daily commented that Let's Roll Tobacco on Broadway is not a location for many calls to the department.*

Fox said Lopas has worked for them throughout the summer; he is a hard worker; Jim, Sue and Dan Taylor speak highly of Lopas as well. Lopas said he doesn't drink too often, in January he was drinking and called Carroll Public Safety for a ride and was cited for underage drinking at that time.*
