**Sponsors:** Patton

*Ald. Patton spoke in interest of business protection in downtown. Bill Huelsman spoke about 3 issues - difficult for public to participate in the process, ordinance doesn't require action by public body or committee. He felt needed to do something about that. Clerk has agreed to publish on the website to take care of that. 2nd issue - discretion of the clerk to process applications in less than the 20 days for good and compelling causes, his suggestion was it unfairly burdened the clerk to waive the 20 day period - reduces further public input. City attorney did not recommend removing that clause so simply a difference in opinion - doesn't suggest going against the city attorneys recommendation. 3rd issue time of 20 days too short - especially special events - review by other depts., issues and time required. Requesting extending the time from 20 to 30. No objection by the City attorney to that additional time.*
