Subject:

Review and act on the Consultant Contracts for 2025, 2027, and 2029 Road Ratings.

Details:

The Department of Public Works solicited proposals for consultants to provide professional services for 2025, 2027, and 2029 Road Ratings. The City is required by WisDOT to submit pavement inspection data to the Wisconsin Information System for Local Roads (WISLR) every odd year. Two firms responded to the request for proposals for professional services. The City's review committee evaluated the responses based on the credentials of the team, project understanding, project approach, and cost/rates. Below are the rankings of the firms:
