Hi Tim,

We are kind of in a pickle here, because we specified a credit meter to the contracted builder. His plumbing sub talked to someone at Water Utility who told him that credit meters were no longer allowed. We didn't find out this information until the pool was filled and most of the season was in the books. Some of the fill water did go through a meter that was off a hydrant(per Tina-275,900 gallons), but the remainder (118,053 gallons) went through the building meter. At the end of the day, we are not asking for anything besides the fill difference to be a one-time credit. There is a significant amount of evaporation and loss from bathers, which we are not looking to speculate usage on. Please let me know your thoughts and if you have any questions.
