Attorney Running stated that the proposed amendment of Waukesha Municipal Ordinance 25.08(2)(b) would authorize a Civilian Community Service Officer or CSO to issue citations for violations of Waukesha Municipal Ordinance 11.09(2)(b)6 (the ordinance which prohibits persons from smoking on City owned property which is posted as no smoking by the City Administrator or his or her designee). It mainly concerns the continuing problem at the gazebo at Bank Street and the Fox River where numerous individuals have been gathering, smoking and drinking.

Police Chief Jack stated that the Police Department is fully in support of this change.

Ald. Johnson stated that he does believe this is a good thing for the CSO's. He is in support.
