Public Works Staff has reviewed this item. This referral was made by Ald. Helgestad. Activity would involve installing pavement surface mounted crosswalk paddle type signs on Grand Ave at Carroll Street. This item was originally requested by St. Luke's Church. However, upon review of the location and talking with the Les Paul School, it was concluded that the paddle signs would be beneficial to school students as well as the church and local residents that use the crosswalks often. The signs would be installed and maintained by the City. Public Works supports this installation.

It has been determined that stop signs are needed on the new northbound approach of Prairie Song Drive. Southbound Prairie Song already has a stop sign. Staff agrees with installing this stop sign. Staff will also bill the cost of

installing the stop sign to the Howell Oaks development.

Prairie Song Drive at Madison Street.
