3. Discussion and Recommendation re:

- A. [ID#15-3731](#) Evaluate enhancing the crosswalk with flashing solar signs at the Waukesha Springs Park crossing on Hartwell Ave and possibly teaming with Parks and Rec for funding and planning.

Sponsors: Helgestad

The committee discussed this held item further. Ald. Payne would like to remove the existing flashing crosswalk signing units, located on St. Paul Avenue at the Transit center, and move them to the Hartwell Avenue crosswalk at Linden Street. In exchange, a new set of crosswalk signs with rrfb (rapid flashing beacon) are proposed to be installed on St. Paul Avenue at the transit center and will be more visible to driver and push button activated. Public works staff shared estimated costs of removing St. Paul flashers, installing them at Hartwell and then installing a new set on St. Paul. Ald. Payne is working with Transit staff to come up with ideas on funding the expected \$10,000 cost of installing new flashers on St. Paul. Ald. Helgestad is working with Parks & Rec to see if some funding can be available to assist with cost to install the relocated flashers on Hartwell Ave. which is expected to be around \$10,000 as well since the crosswalk ramps are to be upgraded.

The committee cannot make a decision at this point until more is known about funding. The committee member unanimously agreed to place this item on hold until March 2016.

- B. [ID#15-3843](#) Establish a Handicap Parking stall in front of Trinity Presbyterian Church at 224 N. Hine Avenue, west side of street.
