RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the June 20, 2016 Buildings & Grounds meeting and brought forward to the July 5, 2016 Common Council Meeting for approval under the Consent Agenda.

ID#16-0994 Approve No Parking Any Time at the following locations:
- north and south sides E. Sunset Drive from Tenny Avenue to 1000 feet east
- north side of E. Sunset Drive from Les Paul Parkway to 1600 feet west
- south side of E. Sunset Drive from Les Paul Parkway to 1200 feet west

ID#16-0995 No Parking Any time on the east and west sides of Tenny Avenue from E. Sunset Drive to 1000 feet south.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
