Landmarks Commission Certificate of Appropriateness for 348 Wisconsin Ave. Review a request to replace rear stairs and a front porch railing top rail (Wisconsin Avenue Historic District).

Additional approval required if lagging is included. 2. Old patch work on front porch must be repaired. 3. New porch railing must match color of the existing railing.
