## RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the January 4, 2016 Buildings & Grounds meeting and brought forward to the January 19, 2016 Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#15-3842      Establish 1 hour parking, 7am to 4pm, Except Saturday, Sunday, Holiday on E North Street between NW Barstow Street and Madison Street.
- ID#15-3903      Install Deaf Child Area signing in the 1100 block of N. Bel Ayr Drive.
- ID#15-3904      Install stop signs on northbound and southbound Makou Trail at Moccasin Trail.
- ID#15-3905      Install a stop sign on northbound Prairie Song Drive at Madison Street.
- ID#15-3906      Install a stop sign on northbound Howell Oaks Drive at Madison Street.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
